### HALAL TOURISM DEVELOPMENT STRATEGY AS A SUSTAINABLE ECONOMY DRIVER BASED ON MAQASHID SYARIAH

#### Abstract

In the era of globalization and rapid growth of the tourism industry, a halal tourism development strategy has become an urgent need to encourage a sustainable economy based on the principles of Maqashid Sharia. This research aims to analyze halal tourism development strategies as a driving element for sustainable economic growth based on the concept of Maqashid Sharia. The research method used is a qualitative approach. The results of this research confirm that halal tourism has the potential to positively impact the economy sustainably. This approach involves key components such as halal food, accommodation that is friendly to Muslim needs, and interactions with religious norms. This creates an environment that is in line with Maqashid Sharia, which involves the protection of religion (Hifz al-Din), soul (Hifz al-Nafs), intellect (Hifz al-Aql), descendants (Hifz al-Nasl), property (Hifz al-Mal), and environment (Hifz al-Bi'ah). In the context of the halal tourism development strategy, three important factors were identified: the development of infrastructure that supports halal principles, the promotion of appropriate destinations, and the implementation of the principles of crowdfunding within the Sharia framework.

### A. INTRODUCTION

Tourism development has become one of the key components in global economic growth, especially in the context of promoting a sustainable economy.<sup>1</sup> This phenomenon

It cannot be separated from the paradigm shift in people's consumption patterns, where more and more individuals are considering aspects of religiosity in their tourism activities.<sup>2</sup> One

The form of expression of religiosity is manifested in halal tourism, which is closely related to the principles of Maqashid Sharia.<sup>3</sup> This global phenomenon has attracted the attention of researchers and practitioners in various parts of the world, considering the economic potential it contains, as well as the challenges to overcome various problems that arise.

Halal tourism has received the world's attention as part of the development of tourism based on Islamic and Sharia values.<sup>4</sup> The 2023 Global Muslim Travel Index (GMTI) report places Indonesia in first place as the best halal tourism destination in the world, beating 140 other countries. This achievement increased from the previous year, which was in 2nd position, and Malaysia occupied the top position. The GMTI report released in Singapore on June 1, 2023, is the 8th edition organized by Mastercard Crescent Ratings. Through an assessment conducted based on four main categories. namely Access. Communication, Environment, and Services (ACES), Indonesia and Malaysia received a score of 73, followed by Saudi Arabia 72, UAE 71, and Turkey 70.

The global phenomenon of halal tourism is becoming increasingly significant due to the growth of the Muslim population around the world and the shift in consumer preferences towards a more holistic and religious value-based travel experience.<sup>5</sup> Muslim tourists are not

only looking for destinations that meet their basic needs, such as halal accommodation and shah-compliant food, but also seeking an indepth experience in understanding the culture and history that aligns with their beliefs. In this context, halal tourism emerges as a concept that accommodates these aspirations and makes a positive contribution to the local economy. Although the potential is great, the development of halal tourism also brings several challenges that need to be overcome.

Maqashid Sharia, which refers to the purpose of Islamic law, which includes the protection of religion,<sup>8</sup> soul,<sup>9</sup> intellect,<sup>10</sup>

descendants, 11 Property, 12 and the environment, <sup>13</sup> plays a central role in the context of halal tourism development. This concept provides a principled basis rich in implications to ensure that halal tourism not only focuses on growth but also fulfills these fundamental goals. In the context of halal tourism, complex challenges arise in various dimensions. The balance between social justice, economic sustainability, and environmental protection is an issue that needs to be taken seriously. How to realize tourism development that not only stimulates the economy, but also upholds the principles of social justice, and answers the needs of the environment in the long term is an important question. In addition, the mismatch between the expectations of Muslim tourists and the reality of the services offered is an important concern. Sometimes, halal tourism is considered limited to a marketing strategy that only highlights aspects of halal food and prayer facilities. This can reduce the importance of other important aspects, such as cultural and religious education, as well as the urgency of an environmentally friendly environment. Understand how reconciling the realistic expectations of Muslim tourists with great offers in halal tourism is an issue that cannot be ignored. On the other hand, overcoming communication and promotion barriers related to halal tourism is also a challenge. Facilities and services related to halal tourism are often available, but the information is difficult to access or inaccurate. This condition can hinder the growth potential of this segment. Therefore, an effective strategy is needed to ensure that

information related to halal tourism facilities and services is easy to find for Muslim tourists so that they can plan their trips optimally. Within this framework, research on halal tourism development strategies as a driver of a sustainable economy based on Maqashid Syariah has very important relevance.

In this study, there are several previous studies, such as Azali et al. (2023) revealed that the halal tourism industry in Malaysia has made a significant contribution to the country's economy. 14 The growth of this industry can be seen through increasing income from Muslim tourists, opening new job opportunities, and developing tourism infrastructure. 15 These findings underscore the importance of developing halal tourism in supporting sustainable economies in Maqashid Sharia-oriented countries.

Research by Tabrani (2018) highlights the importance of applying Maqashid Sharia principles in sustainable tourism development strategies. <sup>16</sup> An emphasis on ethical values, social justice, and environmental protection can ensure that the growth of the tourism industry not only generates economic benefits but also respects the Sharia principles that underlie the lives of Muslim communities.

Research conducted by Putranto et al. (2024) observed the economic impact of halal tourism development in Bandung.<sup>17</sup> The

results of this study show that Bandung has succeeded in utilizing the potential of halal tourism to encourage regional economic growth. The presence of facilities and services that suit the needs of Muslim tourists has increased income and investment in the area.

A study by Pongsakornrungsilp et al. (2024) compares the impact of Muslim-friendly tourism with conventional tourism in the context of sustainability. <sup>18</sup> The results of this study show that Muslim-friendly tourism can have a positive impact on economic and social aspects. In addition to the economic contribution, this approach can also reduce the negative impact on the local environment and culture. From the literature that has been praised, the importance of applying Sharia principles in the tourism industry becomes clear as a strong foundation to achieve sustainable goals in the economy and society.

In this study, several research questions are the main focus. First, what is the correct definition of halal tourism, and what are the distinctive characteristics of this type tourism? Second, what are the principles of Magashid Sharia, which include aspects such as Hifz al-Din, Hifz al-Nafs, Hifz al-Aql, Hifz al-Nasl, Hifz al-Mal, and Hifz al-Bi'ah in directing the development of halal tourism? Third, what is the real contribution of halal tourism in supporting sustainable economic growth, especially in the context of countries with significant Muslim populations? Fourth, what are effective strategies to develop the halal tourism sector, involving aspects such as infrastructure, promotion, and cross-sector collaboration? Fifth, how? Magashid Sharia Application: How can halal tourism practices affect tourist experiences and perceptions, and how this impact local and can global

The purpose of this study is to provide a deeper and more comprehensive understanding of the role of halal tourism in the context of sustainable economic growth and its impact on the tourist experience and local development. Through an in-depth analysis of the definition, principles of Maqashid Sharia, economic contributions, development strategies, and the implementation of halal tourism practices, this research aims to explore clearer insights into this phenomenon.

#### **B. RESEARCH METHODS**

This study applies a qualitative approach to understanding the halal tourism development strategy as a driver of a sustainable economy, focusing on aspects that are in line with Magashid Sharia. Data was collected through library research. 19 Literature studies are used for secondary information related to halal tourism, economic contributions, and the Magashid Syariah approach. The data analysis refers to the five principles of Magashid Sharia: the preservation of religion, soul, mind, heredity, and property. The social and economic impact of halal tourism is evaluated by taking into account Islamic ethics. The main goal is to understand how halal tourism development strategies can achieve these goals comprehensively.

# C. RESULT AND DISCUSSION Definition of Halal Tourism

According to the survey literature, halal tourism is a concept that emerged as a response to the needs and preferences of Muslim tourists in facing the challenges and opportunities presented by an increasingly connected global world.<sup>20</sup> The definition of

halal tourism goes beyond the conventional understanding of tourism as a mere recreational activity, involving various elements related to Islamic religious norms.<sup>21</sup> Halal tourism refers to efforts to create an environment that is by sharia principles, which includes aspects ranging from halal food and beverages to tourism experiences that respect Islamic moral and ethical values.<sup>22</sup>

Halal food and beverages are one of the important pillars in the concept of halal tourism.<sup>23</sup> This requires the provision of food that is prepared and served according to Islamic law, avoiding prohibited substances and illegal methods in preparing food. The importance of halal food and beverages does not only come from the religious aspect but also from the belief that consuming food that is by religious norms will have a positive impact on a person's health and well-being.<sup>24</sup>

In addition, Muslim-friendly accommodation is an important element in halal tourism. Including facilities that make it easier for Muslim tourists to carry out their worship, including comfortable prayer rooms and accessibility to facilities that support religious

practices. Accommodation by Sharia principles also includes the avoidance of forms of entertainment that are contrary to religious values, as well as the comfort and privacy required by Muslim tourists.<sup>25</sup>

More than just physical services, a halalcompliant tourism experience also includes interactions that respect Islamic social norms ethics.<sup>26</sup> This includes developing activities and attractions that promote togetherness and understanding between different cultures, encouraging dialogue and mutual respect. By understanding diversity and facilitating positive cultural exchanges. halal tourism acts as a bridge in building understanding and cooperation between Muslim and non-Muslim communities.

Thus, the definition of halal tourism is a comprehensive effort to create a travel experience that is by Islamic values, norms, and beliefs. It is a response to Muslim travelers' demand for a spiritually, socially, and culturally rich experience, while still considering convenience and practical needs. In the economic context, halal tourism is not only the tourism industry but also the local and global economy, providing growth opportunities, job creation, as well as cultural promotion and intercultural dialogue.

### **Principles of Magashid Sharia**

The principle of Maqashid Sharia, also known as the goal or wisdom of Sharia, refers

to a conceptual framework in Islam that sets out the main objectives of the teachings and laws of the Islamic religion. These principles not only detail religious obligations but also focus on achieving prosperity and justice in human life, both in this world and in the hereafter. This goal guides individuals, communities, and governments in shaping policies and actions that are consistent with religious principles and the common good.

*Hifz al-Din* (Religious Maintenance)

The principle of *Hifz al-Din*, known as the Maintenance of Religion, is a philosophical foundation that conveys the urgency to protect, maintain, and promote the values and teachings contained in the religion of Islam.27 This principle is a strong foundation for individuals and societies to holistically care for religious heritage, maintain the integrity of sacred teachings, and ensure that the social order departs from a deep moral foundation. An integral part of the Hifz al-Din principle is the recognition of the human right of individuals to practice religion without harmful discriminatory interference. In this context, this principle provides a guarantee that each individual has the freedom to organize worship and practice his or her religious principles without pressure or hindrance from others. This freedom is not only a right but also the embodiment of the values of tolerance and respect for diversity of faiths. When the principle of Hifz al-Din is applied in the halal tourism sector, its meaning and impact are even more widespread. This requires the provision of adequate worship facilities and a supportive environment for Muslim tourists when they visit tourist destinations. By creating facilities such as mosques, ablution places, and prayer rooms

that are clean and comfortable, this principle allows Muslim tourists to carry out their worship with full reverence and calm, without feeling disturbed by logistical constraints.

Hifz al-Nafs (Soul Nurturing)

A profound principle known as Hifz al-Nafs, or Soul Preservation, affirms the invaluable value of safety and well-being.<sup>28</sup> This principle inspires a strong moral responsibility to care for and protect the lives of individuals, valuing life as a gift to humanity. In this context, the principle of Hifz al-Nafs has a profound ethical dimension, which guides our daily actions. This principle includes the strict prohibition against actions that may endanger the life or health of oneself or others. Maintaining physical and mental integrity is an obligation that respects the presence of human beings in this world. This prohibition includes not only real actions that can be dangerous, but also mental attitudes and behaviors that ignore the value of safety for oneself or others. Hifz al-Nafs, in essence, is an invitation to live responsibly towards oneself and society. It encourages us to take actions that support healthy and safe living, both in everyday actions and in more extreme This principle underlines the situations. avoiding self-endangering importance of behaviors, such consuming as substances, dangerous actions in dangerous situations, and other actions that can endanger life.

*Hifz al-Aql* (Nurturance of Reason)

The basic principle known as *Hifz al-Aql*, or Maintenance of Reason, describes the essence of maintaining the intelligence and

The principle of Hifz al-Aql brings man to the world a deeper understanding of the power of the human mind. It is not only about maintaining the physical state of the brain, but also involves maintaining the quality of intelligent and productive thinking. This principle teaches us to avoid behaviors or actions that have the potential to damage the mind, such as the psychoactive substances that can damage cognition, as well as actions that disrupt mental balance. Mental health protection is also included in this principle. Mental health is an important component of overall human wellbeing. The principle of Hifz al-Aql encourages a person to avoid excessive stress, unnecessary anxiety, and negative attitudes that can damage the mind. By taking steps to take care of our mental health, such as developing stress management skills, practicing relaxation, and seeking support when needed, we can ensure that our minds remain healthy and functioning optimally. More than just taking care of oneself, the principle of Hifz al-Aql also involves the protection of the minds of others. This includes the responsibility not to worsen the mental state of others or harm their minds. Respect and empathy for the mental state of others are an important part of this principle. In an increasingly complex society, the principles of Hifz al-Aql invite us to consider the impact of the information we consume, the environment around us, and the social interactions we

*Hifz al-Nasl* (Progeny Preservation)

The basic principles of Hifz al-Nasl, or Preservation of Offspring, emphasize the importance of preserving the continuity of human offspring and securing future humans as a species. These principles include family values, responsibility for a healthy marriage, and concern for the welfare of children. In this context, the principle of Hifz al-Nasl encourages us to build a strong foundation for future generations and maintain harmony in family and social relationships. principles include the norms and values that make up a strong and balanced family structure. This involves protecting the rights and responsibilities of each family member, as well as respecting the special role played by each individual in the family. The Hifz al-Nasl principle also emphasizes the importance of children's education and development, providing a safe and loving environment for them to grow and develop optimally.<sup>30</sup>

Hifz al-Mal (Property Maintenance)

The principle of *Hifz al-Mal*, or Property Care, teaches the importance of safeguarding property and possessions fairly and ethically. These principles encourage us to treat property responsibly, avoid actions such as fraud or abuse, and apply fair trade principles. Understanding the property owned in trust gives us a framework for thinking that guides us in the use and management of the property. This principle also invites us to use our possessions for productive and useful purposes, both in personal aspects and in

*Hifz al-Bi'ah* (Protecting the environment) The principle of *Hifz al-Bi'ah*, Protecting the Environment, underlines the importance of safeguarding and protecting the natural environment and all forms of life in it.32 This principle encourages awareness of our responsibility for ecosystem sustainability and the need to avoid environmental damage. The principle of *Hifz al-Bi'ah* invites a person to take action to maintain the balance of nature and prevent environmental damage. This involves wise management of natural resources, efforts to reduce our ecological footprint, and support for broader environmental protection efforts. This principle also encourages us to appreciate and respect all living things as an integral part of our existence on the planet.

The principles of Maqashid Syariah provide an ethical and moral basis for designing halal tourism development strategies.
