The right of local communities to express opinions in the form of ideas or ideas needed for the smooth running of the development program that will take place later, and in order to achieve the expected goals. either directly or by their representatives in a meeting forum or joint discussion. which is intended as a provision for the long term for future generations as well as democratic rights for the people in their area (Article 7 Paragraph 4).

Positively, the community participates in development and implementation programs as they take place, from the start of making decisions on planning, monitoring, and supervision policies (Article 14 Paragraph 1) and efforts to distribute results equally according to the functions and sacrifices that have been made.
